Annual Congregational Meeting Minutes – June 4, 2017

- The meeting was called to order at 12:10 by Felice Killian-Benigno, President with the chalice lighting.
- <u>Quorum</u> was certified at 43.
- <u>Moderator</u>: Marilyn Lyman was nominated and elected Moderator.
- <u>Consideration of Congregational Minutes:</u>
 - 1) Acceptance of the Minutes from June 5, 2016 were motioned and seconded. Approved.
 - 2) Acceptance of the Minutes from Special Congregational Meeting May 7, 2016 were motioned and seconded. Approved.

<u>Nominations for Life Members:</u> Felice spoke of the criteria for being voted a Life Member and read a list of previous Life Members through 2016. This year the Board has nominated <u>Cliff Mellor and Marge</u> <u>Mellor to become Life Members</u>. Marge has served on almost every committee and as President. Cliff has been involved in finances and our Trust investments for many, many years, most recently chairing the Capital Campaign Committee.

Receipt of Annual Reports for 2016-2017:

King); Capital Campaign Committee (Cliff Mellor); Community Outreach (Rick Olanoff); Community Care and Growth Ministry including Caring Team, Hospitality, Membership (Randy Kalish) including list of new members to the congregation; Worship and Music Ministry (Paul Barfoot); and Congregational Relations Committee (Valoree Suttmore). All reports were accepted adding thanks to the Minister's report for Kelley Williams and Karen Bowman for their participation in Beyond the Binary.

<u>Nominating Committee slate</u> was read by Peggy Flanders, Clerk for Keith Bertrand, Chair. Ballots were distributed for Election of Officers, Trustees and Nominating Committee. <u>Written Ballots were collected and counted</u>. **Nominations were approved unanimously.**

Note: Continuing on Nominating Committee, no vote needed: Keith Bertrand & Betsy Spaulding. <u>First Unitarian Universalist Society Constitutional Changes :</u> Rev. Jennifer summarized the changes that were sent around by electronic mail, or U.S. mail for those members who do not have e-mail. In answer to a question, there was no forum on the changes before the meeting.

- Life Member Category change is the addition of a Lifetime Right to vote without making a financial contribution of record. The spirit of the change is having the status of Life Member be a true honor with all privileges of membership
- Active or Voting Member: Change defines what determines a voting member: Formerly signing the book and making a financial donation of record was the criteria. Criteria will add: Actively involved in regular activities of the church. In answer to a question about who makes the decision about active participation, with consultation to the UUA, that would be the Minister and the President of the Congregation. If the person is not able to be active or in cases of financial hardship, there is presently a method in the constitution to apply for a waiver of financial contribution
- The title of the Director of Religious Education will change to the Director of Lifespan Religious Education.

After a discussion, Claudia (Coran) Klaver moved and Sunny Aslam seconded to accept the changes as presented. Two thirds of the members present are needed to approve.

• MOTION was approved; No votes to abstain or oppose.

Adoption of the Operating Budget for the 2017-2018 Fiscal Year: Rev. Jennifer summarized the presentation for Susan King who could not be present due to family illness. Items of interest: Budget includes 3% raises for staff. We are not yet at Fair Share in the UUA (\$2,500 to district and UUA instead of \$5,000). Discussion centered on whether we should draw more than \$26,000 from the Endowment fund order to be fair share and balancing between using Endowment funds and regular income, including pledges, in order to be prudent. Additional fund raisers were discussed. Dennis spoke positively about investment for growth at First UU. The raise for staff was commended since compensation doesn't match the work staff do for the congregation. A MOTION was made and seconded to pass the budget as presented. VOTE: Most in favor, one opposed, one abstention.

<u>Capital Campaign Project Phase 2A was distributed</u>. Jim D'Aloisio spoke about the specifics as presented in the memo to the President from the Facilities Team dated May 19, 2017. Items included: Rear Parking Lot Design Services; Architectural Design Services for Handicap Accessibility; Handicap Lift from the lower level to the classroom wing; Replacement of Furnace in nursery for East Room; Sanctuary Sound and Light System Improvements; and Contingency and Finance costs. <u>Total \$40,000 MOTION made and seconded:</u> Propose we approve the work and cost expenditures identified as Capital Project Phase 2A. **VOTE: Different hand counts by those tallying voting cards but most in favor. No votes to abstain or oppose.**

Motion to adjourn was made at 1:20 p.m. The meeting was closed by Extinguishing the Chalice.

Special Congregational Meeting January 21, 2018 DRAFT

Meeting Called to Order at 12:00 pm by Peggy Flanders, Clerk –Quorum certified. Felice Killian-Benigno, President, led the lighting of the chalice.

Nomination and election of a Moderator: Coran Klaver was moved, seconded and approved.

Minutes from the June 1, 2017 Congregational Meeting were circulated and approved.

1. Motion to approve hiring a Ministerial Intern for 2018-2019 was presented as approved by the Board on 12/17/17:

<u>"MOTION: (Proposed and Seconded) First UU as a congregation commits itself to growth and as such the</u> <u>congregation commits to the hiring of a full-time intern for 2018-19. The congregation recognizes that</u> <u>this will increase our expenditures. The congregation commits to paying for those expenditures by</u> <u>increasing pledges and/or drawing funds from our savings/investments."</u>

Discussion: 1) Salary arrangements yearly \$14,500. Fifty per cent will be supported by the UUA (\$7,250) as long as we meet our Fair Share donation to the UUA (an increase from this year). 2) Focus for the intern as an investment in growth, (we presently have 70 pledging units), programs, supporting staff and youth program. planning for the future. Rev. Jennifer Hamlin-Navias, as settled minister, is ¾ time. We realized how important it has been to have Bethany Russell-Lowe as our shared ministerial intern with May Memorial for the last two years. Our Membership Committee doesn't have the resources to market First UUs activities to the community (presently have 70 pledging units). Internship is a requirement to achieve ordination and a congregation such as ours is attractive on many levels, including our size and need for growth. Jennifer plans to do the interviews but hopes to have a committee in place if we decide to do this in future years.

MOTION, AS STATED ABOVE, APPROVED. MOST IN FAVOR (Not counted but probably 33 votes.) TWO ABSTENTIONS.

2. <u>Motion to endorse Carbon Fee and Dividend proposal of the Citizens' Climate Lobby.</u> The Motion was read as approved by the Board on 12/17/17:

<u>"MOTION: First UU Society of Syracuse affirms the Citizens Climate Lobby Carbon Fee and Dividend</u> Policy and agrees to have our name added as an endorser." (Attached)

The actual wording of the petition was circulated for a counted vote. Jim D'Aloisio, Treasurer, corrected the typo of \$125/ton in paragraph 3 to \$15/ton.. Sunny Aslam outlined the economic model that this will support.

MOTION PASSED: 34 IN FAVOR, ONE ABSTENTION.

Summary of our capital projects so far was reviewed by Jim D'Aloisio. Phase 2A included funding for design but not actual construction.

I/We Endorse Carbon Fee & Dividend

The costs of climate change—including destabilized weather patterns, rising sea levels, extreme weather events, and other serious impacts— now pose a substantial threat to the health, prosperity and security of Americans. The costs are real, they are growing, and they are already burdening businesses, taxpayers, municipal budgets and families. Our economy, infrastructure, public safety and health are directly at risk.

Therefore, I/we urge Congress to support Carbon Fee & Dividend as a key element in reducing the risks of climate change. Carbon Fee & Dividend will significantly reduce carbon emissions, create jobs, grow the economy, save lives and protect households from higher energy prices.

Carbon Fee & Dividend will place a steadily increasing fee on fossil fuels at their source (the well, mine, or port of entry), beginning at \$15 per ton of CO₂ emitted, and increasing each year by \$10. All revenues will be returned in equal shares to American households as a monthly dividend.

Additionally:

- A predictably increasing price on carbon will send a clear market signal that will unleash entrepreneurs and investors in a new clean-energy economy.
- With all of the revenue returned to households on an equal basis, two-thirds of households will break even or receive more in dividends than they would pay in higher living expenses.
- A border adjustment will discourage domestic businesses from relocating where they can emit more CO₂ and encourage other nations to adopt an equivalent price on carbon.

In the Spring we hosted the Building Beloved Community Beyond the Binary and welcomed 125 people into our building that day. In March we hosted the ordination of Bethany Russell-Lowe. We and May Memorial planned the event and ordained her. It was a joyous and wonderful day. In April we hosted the Gould lecture and the Seaway Gathering for the UU churches in NYS (minus the NYC area).

Your facilities team has been working hard. Matt Irish who has been heading that team up this year has done a phenomenal job! Much of their work is behind the scenes but so important. I can't name every project they have taken on but a special shout out for the new sump pump. Our fellowship hall is as dry as it ever has been.

Along with all those happenings we had potlucks, and music gatherings, chalice circles, discussion groups, movie nights, fundraisers and on and on.

Yes, there was a lot of activity at our congregation this year. Each year I see our congregation get a little bit stronger and vibrant. I am looking forward to next year!

Lifespan Faith Development Director Report

Our children and youth ministry continues to thrive! This year we had an average of 21 children and youth in the building on Sunday mornings. We had 42 children and youth registered in our program. Our children and youth ranged in age from 1-18.

We had a small but mighty group of adult volunteers and staff in our program this year working with our children and youth. **Thank you to everyone who took time to work with our young people!** Some of you gave up every Sunday for the entire year, some gave a few Sundays over the course of the year. ALL of you were important to making our program a strong, inspiring place for our children and youth to explore their faith and grow as individuals and as a community.

This year our children in kindergarten through sixth grade primarily used the Harry and UU curriculum. Based on the Harry Potter books, this curriculum was designed for kids to learn about and fight injustices in our world. Some of the highlights from the program this year include collecting hundreds of children's books to donate to St Lucy's food pantry, learning about immigration justice issues, collecting money to help with disaster relief and the creation of an anti bullying public service announcement video. The children in this program amazed me with their thoughtful conversations about race, politics, environmental issues and other justice issues. We have an inspiring and creative group of kids.

Our collaboration with May Memorial for our middle and high school programs has continued to thrive.

This year we ran the Our Whole Lives program with 19 young people and 6 adult volunteers. The class had two evening sessions where they had the chance to learn and socialize outside of Sunday morning. Our class this year included kids from May Memorial, First UU, the Humanist Association as well as community members. This is an important ministry that saves lives and I am proud of our congregations and denomination for providing this intensive class for the young people in our community.

Our collaborative Teenz (high school) program is also highly successful. We have about 25 youth registered and 12-15 who participate regularly in our Sunday morning programming. Many youth attended social CONS, we had two who youth served on the Youth Adult Committee and many who attended trainings hosted by our region. Our youth successfully hosted a leadership con this fall,

fundraised for their service/learning trip to West Virginia, put together an inspiring worship service and supported each other over the year.

With the support of both congregations we were able to take five youth to West Virginia with the UU College of Social Justice for a week of service and learning. The entire youth group did much of the pretrip study work including lessons on white supremacy, the intersectionality of oppressions and privilege. The youth attending the trip also learned about West Virginia history, coal mining, labor organizing, environmental justice issues and the long history of exploitation or workers and communities in Appalachia. Partnering with the Southern Appalachian Labor School we spent a week side by side with youth and young adults from rural West Virginia doing construction, talking, laughing and learning from each other. The UU church of Charleston hosted our group overnight provided us with dinner and conversation. We spent time with historians, activists and local people engaging in conversations and learning about issues that impact our communities. Our youth came away from this experience with a plan of action for how to create change around local issues of poverty and violence.

I am so proud to be serving such a strong religious education program. We have an amazing group of young people who are developing their love of UU and who have developed a community of friends unlike other places in their lives. I am looking forward to next year and all the growth and change ahead.

These numbers do not include the people participating in the Potluck and Music Jam Sessions, led by Dennis Killian-Benigno, or the May Memorial people who joined us for Bethany's ordination.

We sang 82 individual hymns this year. Most of the new choir music I purchased was either by a UU Musician Network member, or introduced to me at their summer conferences. A few pieces were from the Hymn Society conference. A variety of instruments were used in our services, including organ, piano, flute (including alto, bass and contrabass), percussion, guitar, clarinet, harp, accordion, trumpet, saxophone, trombone, djembe, cajon, kazoo, violin, mandolin, viola, kazoos, hammered dulcimer.

This year I successfully completed the last 3 of the 9 courses required for my Music Leader Certification program, a program through the UUA and UUMN. I will be recognized for this accomplishment in the Service of the Living Tradition at General Assembly in June. The courses included Ethics and Care: The Ethics of Self Care, Leading a Choir Rehearsal: Tools and Techniques for Success, and our Professional Development Day at the UUMN conference: Unitarian Universalist History, Theology and Race. My community service project from this program had us open our Potluck and Music Jam Sessions to area English Language Learners through CNYLiteracy, but unfortunately did not see much success.

Our 2 Music Sunday topics: the 500th Anniversary of Luther and our Intergenerational Earth Day Service were both well received and fit the monthly Soul Matters themes. We continued a larger Christmas Choir, the Easter Band, and the Hymns of the Month. I am planning on continuing all these things next year. They increase participation in our music program, expand our hymnody, and help support our worship. I also planned and led 3 Vesper Services with Rev Bethany in November, December, and March, plus a Vigil with Rev Jennifer in October.

I also continued playing music for a few of the Nottingham services. I was unable to be there as often as in previous years due to scheduling and family health.

Concerts at FUUSS this year included the CNY Flute Choir, the CNY Baroque Ensemble and area music teachers. We did not host any concerts or fund-raisers as volunteers have not stepped forward to promote these events. If you're looking for short commitments for next year, please see me. Hosting UU musicians is an excellent was to spread our faith throughout the Syracuse area.

Summer services included a few song leaders this year. Special thanks to Anthony Ragonese, Dennis Killian-Benigno, Deb Sprague, and Pamela Anderegg.

Ministerial Intern Report

What a full year it has been! And what an amazing two years it has been spending time with you all at First UU Society of Syracuse and May Memorial UU Society. It has been a pleasure and honor to serve as your shared Ministerial Intern these past two years.

I came to you all two years ago expecting to work on expanding the collaborative ministries of the two congregations. You are two healthy and yet different UU congregations 2 miles apart – there had to be room for collaboration there! Once I arrived, I quickly realized that you all were (and are!) already doing collaborative ministry with excellence. My ministry role became one of holding up the mirror to that work, finding ways to strengthen it, and working with you all to find more potential for collaboration. This is the work I have focused on with you all, and I feel we have accomplished so much together.

This past year, for the first time in recent memory, the social justice committees at First UU and May Memorial met twice, and the leadership of the two committees met one additional time. The two committees worked together to plan a forum on the I-81 renovation project and also collaborated on tabling efforts for the NY State Fair Pride booth in August, the Westcott Fair in September, and Pride Festival booth in June. I am hopeful that these committees will continue to meet regularly to support one another's work and find more ways to work together.

I also worked with the Teenz again this year in a supportive and pastoral role. We have an amazing group of high schoolers who understand and are committed to Unitarian Universalism. One of the wonderful pieces of that group is that they do not distinguish between being members of First UU and May Memorial. They are UUs in Syracuse. Like has happened many times in our larger UU history, our youth are leading the two congregations into greater partnership with one another.

Another collaborative effort between the two congregations was my ordination in March! What a fabulous day! It was such an honor to be ordained by the two congregations! And the collaborative spirit of that event shone through the worship service and the reception.

Two other projects I worked on at First UU as part of my internship were the White Supremacy Audit and the Intern Handbook. The White Supremacy Audit was the creation of Coran Klaver, Radell Roberts, and myself this winter. The idea is that a small group of people who regularly meet (a committee, a chalice circle, the choir, etc.) agree to have two facilitated discussions about white supremacy culture and its impact on their work as a committee/group. In the first conversation, we examined the ways in which the committee or group is already dismantling and upholding white supremacy culture. One or two months later, the group meets again and has a second conversation focusing on how they will continue to dismantle white supremacy culture in their work together. We piloted this project with the Worship and Music Ministry, the Board of Trustees, the Community Outreach Ministry, and the choir at First UU. All conversations were quite successful and we received good feedback from this pilot.

I have also been working on an Intern Handbook to give future interns at First UU a quick introduction to the people, procedures, and processes of the congregation. This document is meant to be edited year after year, as new interns come to First UU. My friend and colleague, Marty Pelham, will be serving First UU next year as a full-time intern. I am so excited by the potential of this ministry next year!

Thank you for supporting me, challenging me, and growing alongside me these past few years. I will hold the UUs in Syracuse in my heart for years to come. You were the place where I came into my own, as a minister. I will treasure this time I have spent with you. Be well.

President Report

This last year has been one of much energy, cooperation and working together for the Board. In the beginning of the year, we brainstormed our hopes and dreams for what we could work together on for the betterment of First UU and, through that, our community. Although we did not get to accomplish all of our dreams (yet) the year was full of much collaborative efforts toward growing and learning together and working toward building the blessed community here in Syracuse. And as I look back on the highlights of this year, I want to give credit to all the board members and also to the efforts of the staff and the members of the congregation who worked with us to discover and address what needed to be done.

In response to and working toward racial justice:

After voting as a congregation to hang a banner in support of Black Lives Matter, the banner was hung this year and received positive comments from the community and other faith communities.

Rev. Bethany and Coran Klaver presented the White Supremacy/White Privilege Culture Inventory to the Board. This experience was an opportunity to become aware of areas where we experience white privilege and consider that how we see things may not be the way all people see or value aspects of different cultures or that one is right or better. It is hard to look at the world the same way after your eyes are opened in this way. It also enabled the Board to use such awareness when making decisions. Thank you Rev. Bethany and Coran.

Denominational Work

In October I attended the New York State Convention of Universalists in Albany. This is the group that granted us an interest free loan for some of our recent renovation work. I also attended their meeting at which we planned to serve as the host church for their convention this year at First UU on October 19 and 20th.

To establish a quorum for some of our Board meetings, we needed to have some members join and participate in the meetings via Zoom, a video conferencing app. A Board vote cannot be considered valid if it is just done via emails but with the video conference, we could all be involved in the discussion and therefore legally be included in the vote. This technology enabled us to complete our tasks in a more timely manner rather than waiting until we could all be together in person.

We began the discussion and work of how we might be able to use our assets in a more socially responsible manner. Some of our finances are now managed through a credit union and we continue to look at the possibility of socially responsible investing.

At our Congregational Meeting in January, we voted to publicly make a statement on the Carbon Fee and Dividend Policy. We also voted to commit to funding an intern for next year who will work with the congregation to help us grow. We have so much that we stand for and work for together that is good and needed in today's world. This commitment to work for growth will give us the opportunity to insure our continued presence in the community.

I want to thank all of you who have helped me as I served as Board President. I was apprehensive when I agreed to serve, but with the help and support of so many, I have enjoyed this opportunity to learn

more about the workings of First UU, to get to know the staff and many of the members and friends and to have an opportunity to have a part in the good work that we do together. Thank you to the Board members who worked together with respect and commitment and a willingness to seek out the best outcomes. Thank you to Sara Jo, Tina and Melissa who actively participated in the Board meetings and tasks and answered all my questions. Thank you to all the committee members for the work you do to maintain and enrich our community. Thank you to Rev. Bethany who has brought so much to our congregation these past 2 years - ideas, energy and the joy and spirit of her ordination. Thank you especially to Rev. Jennifer who has patiently helped me and the Board to grow and work together and has inspired us to further the love and spirit of First UU.

Community Outreach Report
